AFFIDAVIT FOR SEARCH WARRANT  
FOR EVIDENCE OF:

Murder  
(Name of Felony Herein)

Det. Mark Burbridge, being first duly sworn on oath, deposes and says:

**(1) Background of affiant:**

Affiant has been a police officer with the City of Spokane since 1988. He is a detective currently assigned to the Major Crimes Unit. Affiant has been assigned and promoted to positions within his employment which include, but are not limited to, Special Investigative Unit (narcotics), Undercover Investigations, SWAT Team member and Bomb Squad. He has attended numerous schools and seminars dealing with the investigation of serious crimes, including narcotics manufacturing and trafficking and homicide. He has applied for and been granted search warrants dealing with those crimes.

**(2) Crime being investigated:**

Murder

**(3) Circumstances supporting probable cause:**

On 3/10/07 at approximately 2300 hours Jon Lytle arrived at Deaconess Medical Center with his four year old daughter, Summer M. Phelps, WF, 7/6/02. Jon Lytle told medical personnel Summer was found in the bathtub, unresponsive. Medical personnel found Summer in full arrest and unresponsive. Medical intervention was attempted, but unsuccessful. Medical personnel suspected Summer was the victim of vicious child abuse which resulted in her death. Medical personnel were basing their conclusions on Summer's extensive serious bruises, burns and possible head injury.

Patrol officers arrived at Deaconess Medical Center and secured Summer Phelps' body in the trauma room. Jon Lytle was asked to wait in the private family waiting room. Jon Lytle agreed to do so. Jon Lytle told patrol officers that Summer would injure herself by throwing herself on the floor and sometimes into objects. Jon Lytle said a couple days ago, he noticed Summer sleeping with her face against the steam radiator in their apartment. Jon Lytle believes this is how Summer's lip, nose and forehead were burned.

Patrol Officers Chris Crane, Lydia Gorman and Kurt Vigessa went to 707 N. Monroe #25 to secure the residence as a possible crime scene and check on the welfare of a second child at that location. Officers knocked on the door and received no response. Officers believed they heard someone inside. Officers retrieved a key for the apartment from the apartment manager. Officers made entry and found Adriana Lytle and her six month old son, Johnny Lytle, in the apartment. Adriana Lytle commented, "The reason I didn't answer the door is because Jon told me not to when the police came." Jon Lytle said this to her as he was taking Summer to the hospital this evening.

Ofc. Tony Meyer secured Jon Lytle's vehicle outside of Deaconess Medical Center. Jon Lytle's vehicle is a 1992 Chev Blazer, WA license 102 LWM. This vehicle was used to transport Summer to the hospital. Ofc. Meyer arranged for this vehicle to be towed to the vehicle processing station pending a search warrant.

Your affiant, Det. Hamond and Sgt. Brad Arleth viewed Summer Phelps' body. Summer was laying on her back on a gurney. Visible on the front of her body was serious bruising over both hips. These bruises were both approximately eight inches in diameter. Outlined within the bruise on Summer's right hip, your affiant can make out a palm print and finger impressions. Summer has a red abrasion on the center of her chest. This abrasion is approximately an inch and a half in diameter. Both of Summer's arms and shoulders are deeply bruised. Outlined within bruises on Summer's right triceps area, your affiant can make out a hand impression and finger mark. Next to this hand bruise,

your affiant saw a bite mark. This bite mark is the size of a small adult mouth. Summer's face and forehead are bruised and swollen. Summer's eyes are swollen and red. Summer's upper lip, nose and forehead area have a serious vertically oriented burn on them. Your affiant checked Summer's head and found a large soft mass behind her left ear. Your affiant noted a large amount of Summer's hair was gone from her head. Your affiant checked Summer's back, finding numerous overlapping linear bruises. Your affiant found a large linear bruise ending in a bulbous area on Summer's buttocks. In your affiant's experience, this type of injury is consistent with being struck by a large spoon or ladle. Your affiant has seen numerous abused and murdered children. The injuries Summer received are consistent with a series of injuries received over several days. The bruises are in several different stages of healing.

Your affiant and Det. Hamond while viewing Summer noticed her rectum was distended, black and blue and seeping a clear substance. The severe bruises oriented over Summer's front pelvis area could be consistent with someone grabbing her from behind to control her while sexually abusing her.

Your affiant and Det. Hamond interviewed Jon Lytle at the Major Crimes Unit's interview room. Prior to interviewing Jon Lytle, Det. Hamond read to him his constitutional rights which he stated he understood and waived. Jon Lytle signed the rights card. Jon Lytle said Summer is his daughter by another woman, not his current wife. Jon Lytle identified Summer's mother as Elizabeth Phelps. Jon Lytle said Elizabeth has custody of Summer, but last August Elizabeth called and asked if Summer could live with him for a month. Jon Lytle said Elizabeth calls once in a while, but has not asked for Summer back and has made no arrangements to regain custody.

Jon Lytle said Summer is a difficult child and can be abusive to herself and has damaged their apartment on occasion. Summer regularly urinates in her clothes and on the floor. Jon Lytle said Summer would get upset when he or Adriana Lytle would make her clean up her messes after peeing on the floor. Jon Lytle said Adriana Lytle video taped Summer for four hours one day while Summer was having a temper tantrum. Jon Lytle said this video tape is in the house near the TV.

On Saturday, 3/10/07, Jon Lytle said he woke up at about 0800 hours. Adriana Lytle was just waking up to care for Johnny Lytle, their six month old son. Summer had urinated in her clothes and on the floor. Jon Lytle said they regularly make Summer clean up her mess and wash the towels out when she's done. Summer is made to wash the towels by hand, filling the bathtub with water, soaking the towels and repeatedly wringing them out. Jon Lytle said Summer did this from about 0830 until about 1000 hours.

Jon Lytle said a First Step Nurse regularly comes to their house to check on Johnny Lytle. Jon Lytle mentioned the First Step Nurse was coming by on 3/10/07. Jon Lytle said he took Summer for a drive to Cheney so Summer would not disrupt the nurse's visit. Jon Lytle said while in Cheney, he stopped in a parking lot of a grocery store and talked with Summer about cleaning up her messes and being a better girl. Jon Lytle said he called home at about noon and found that the First Step Nurse was still there. Jon Lytle said he

took Summer to a comic book store for another half hour prior to returning home. Jon Lytle said they arrived home at about 1230 hours.

Jon Lytle said Summer went into the bathroom and began cleaning her clothes without being asked to do so. Summer had "a large pile of towels and clothes she had to clean." Summer was mad about the amount of work she had to do and kept throwing herself on the floor. Jon Lytle said he heard Adriana Lytle in the bathroom yelling at Summer "a little bit".

Jon Lytle said Adriana Lytle put Summer in the bathtub at 2200 hours to take a bath. Jon Lytle said he assumed Adriana Lytle put fresh water in the bathtub. Adriana Lytle kept going in and out of the bathroom, trying to keep an eye on Summer. Jon Lytle clarified that Summer had been in the bathroom from 1230 to 2200 hours, cleaning clothes.

Jon Lytle said sometime around 2200 hours Kentucky Fried Chicken was delivered to their apartment. Jon Lytle mentioned that Summer had not eaten since breakfast, but would have been fed when she was done cleaning her mess.

Jon Lytle said he was working on the computer and watching South Park on TV when Adriana Lytle yelled from the bathroom, "Get in here now." When he arrived at the bathroom door, Jon Lytle saw Summer on the floor and Adriana Lytle was giving her CPR. Jon Lytle said he realized the CPR was not working so he grabbed his clothes, put a coat on Summer and drove her to the hospital. Adriana Lytle told Jon Lytle as he was leaving with Summer, "I think I killed your daughter."

Adriana Lytle said Summer is her stepdaughter and has lived with them since August of 2006. Adriana Lytle said she is miserable about Summer living with them. Adriana Lytle described Summer as defiant, a "handful", destructive. Adriana Lytle told Det. Ferguson she wished Summer had never come to live with them.

Adriana Lytle said Summer spent the afternoon and evening cleaning towels and clothing she had peed in. Adriana Lytle said when Summer was done cleaning the towels, she put Summer in the bathtub. Adriana Lytle said she saw Summer under the water with just her nose sticking out, blowing water into the air. Adriana Lytle said she made Summer empty the water from the tub. Adriana Lytle said when she returned, Summer was on the floor with a wet t-shirt over her face. This is the first time Adriana Lytle noticed something wrong with Summer.

Adriana Lytle admitted she has spanked Summer with a belt which has caused bruising. Jon Lytle said he recently spanked Summer with a belt. During this spanking episode, Summer was wearing a blue sweat suit. Adriana Lytle admitted slapping and biting Summer because Summer kicked her. Adriana Lytle said she tried CPR on Summer by placing her foot in the middle of Summer's chest and pushing up and down. Adriana Lytle admitted to Det. Ferguson that Summer does look like an abused child.

Patrol Ofc. Crane noticed small adult sized wet footprints in the carpet, leading from the victim residence to the main door of the apartment complex. Ofc. Crane checked the dumpster and noted couch cushions, afghan and at least one bag of clothes. This dumpster is being secured pending this search warrant.
